

## CARLAS USA PAINT PROTECTION FILM LIMITED WARRANTY

This warranty is valid solely for the Product applied by an authorized Carlas USA dealer or installer ("Dealer") within the United States or Canada, in accordance with the Manufacturer's application guidelines and applicable legal requirements. The Manufacturer disclaims any responsibility for issues stemming from improper or faulty installation by non-authorized entities.

This warranty exclusively covers Products designed and warranted for application on fully cured OEM (Original Equipment Manufacturer) vehicle-painted surfaces. Installation over repainted, aftermarket paints, or vinyl substrates renders the warranty void. Repainting vehicle surfaces is not included in this warranty. Furthermore, the Manufacturer bears no liability for the reapplication of ceramic coatings in the event of a warranty claim. Products installed on non-painted surfaces, including but not limited to headlights, indicator lights, chrome, or carbon fiber trim, are excluded from this warranty. The warranty is non-transferable and applies solely to the original purchaser.

Dealers are prohibited from modifying or extending the terms of this limited warranty. The Product must be utilized in compliance with pertinent laws and regulations. Any warranty coverage shall be void in cases of abuse, improper care, or the use of abrasive or unauthorized cleaning agents. The application of non-wax coatings or supplemental clear coats (excluding authorized ceramic coatings) also voids the warranty. The Manufacturer assumes no liability for damage to either the Product or vehicle resulting from improper installation or inadequate maintenance. Additionally, the durability and hydrophobic characteristics of the Product may be influenced by environmental conditions and external factors beyond the Manufacturer's control, including road treatment chemicals and cleaning methods and frequency; such elements are explicitly excluded from warranty coverage. THE MANUFACTURER DOES NOT ACCEPT RESPONSIBILITY FOR DAMAGES OR STAINS ARISING FROM EXTERNAL ELEMENTS.

Should the Product fail to meet the warranty terms during the specified period, the purchaser is entitled to a replacement Product at no charge, which includes the removal of the defective Product and the installation of the replacement. This service is accessible through any authorized Carlas USA Dealer in the U.S. or Canada per the warranty stipulations. The Manufacturer's obligations under this warranty are strictly confined to the remedies described herein. To initiate any warranty claim, proof of purchase and a completed warranty registration card are necessary. It is crucial for the purchaser to retain the warranty registration card along with the original receipt, with the Dealer responsible for providing all requisite information on the card.



To the fullest extent permitted by law, the Manufacturer disclaims liability for any incidental, special, consequential, or punitive damages arising from any cause, except as explicitly stated in this warranty. The Manufacturer does not extend any express warranties and, outside the defined warranty period, disclaims all implied warranties, including, but not limited to, merchantability and fitness for a particular purpose. Certain jurisdictions may not allow the exclusion or limitation of incidental or consequential damages or the restriction of the duration of implied warranties. Thus, the exclusions or limitations outlined may not be applicable to you. This limited warranty stipulates specific legal rights; you may have additional rights that vary by jurisdiction.

Using or installing the Product in a manner that contravenes any applicable law is categorized as misuse, resulting in the nullification of all warranty coverage, including both express and implied warranties. The onus is on the vehicle owner to ensure compliance with all relevant legal standards.

To maintain warranty validity, adherence to all prescribed care instructions for the Product is essential. Warranty coverage will be forfeited if the Product experiences abuse, inadequate care, or exposure to abrasive or unauthorized cleaning agents. The Manufacturer disclaims any liability for damage to the Product or vehicle resulting from improper maintenance practices.

The warranty registration card should not be accepted unless all necessary details regarding the vehicle, Dealer, and Product have been duly filled out.

## RECOMMENDED CARE FOR CARLAS USA® PAINT PROTECTION FILM

To secure optimal performance of the Product, adhere to the manufacturer's guidelines for exterior surface care. For maintenance, wash the vehicle manually using soap and water. To bolster protection and maintain gloss, apply a non-abrasive wax two to three times annually. Refrain from utilizing automatic car washes, high-pressure nozzles, steam, or power washers near the edges of the Product to prevent delamination. The Product may require up to 30 days to fully cure; during this interval, minor haze and condensation may occur.
